

# Auction of 3G and BWA Spectrum

Information available for download during the auctions

March 2010

## 1 Introduction

This note gives an extensive overview of the format and information contained in the files that will be available for download to bidders during the 3G and BWA auctions in India. It should be read in conjunction with the user manual for DotEcon's electronic auction system, WebBidder (the EAS manual).

During each of these auctions, there will be a number of data files available for download through the electronic auction system:

- 'Round data' files, which contain current information about Round Prices and (where applicable) the Bidder's Provisional Winning Bids;
- 'Auction history' files, which contain, for each completed round and each service area Aggregate Demand information, Round Prices and (where applicable) the Bidder's Provisional Winning Bids at the start and at the end of the Round; and
- 'Decision summary' files, which contain aggregate information on the Bidder's own Bids across all service areas for all completed rounds.

This document sets out: when during the auction these files will be available and updated, how to download them, a description of the file types, the fields that each of these files will include and the format of outputs populating these fields.

Sample files corresponding to those described in this document are available for download from the DoT website. All data files will be in tab-separated value format with Windows-style line breaks. It should be possible to open these in a text editor, spreadsheet or database programme.

## 2 'Round data' file

### Information contained in the 'Round data' file

'Round data' files containing information on the current round will be available from the EAS when the current round is scheduled until the round closes. If one or more Bidders go into extension, the 'Round data' file will still be available during the extension period. This file can be used to obtain a summary of Round Prices by service area and to identify where Bidders may need to make further bids. Thereafter, this information can be obtained from the auction history.

To download the status and value of its bids at the start of a particular completed Clock Round, a Bidder can click on the 'Round data' link on the control panel. A window will then appear asking whether the file should be opened or saved. Bidders should choose the preferred option and click "OK".

If a bidder chooses to save the file, the resulting downloaded file will be of the form '**RoundData\_X.tsv**' where **X** is the number of the Clock Round for which data on the status and value of the Bidder's bids are included.

The downloadable 'Round data' file will consist of a file with:

- a single header row describing the field; and
- a row for each service area containing tab-separated values for each field.

A list of these fields and the format of the output in each case is displayed in Table 1 below:

### **For the first Clock Round**

The 'Round data' file for the first Clock Round becomes available after the Auctioneer has scheduled the first round and will be available to the Bidder until the end of the round. If one or more Bidders go into extension, the 'Round data' file will still be available during the extension period. The 'Round data' file for the first Clock Round will not be available after the end of the first round. The 'Round data' file for the second Clock Round will then be made available as soon as the Auctioneer has scheduled the second Clock Round. An illustration of the contents of a 'Round data' file that will be available for download during the first Clock Round is provided in Figure 1 of the Annex.

### **For all other Clock Rounds**

The 'Round data' file for a Clock Round becomes available after the Auctioneer has scheduled the first round and will be available to the Bidder until the end of

the round. If one or more Bidders go into extension, the 'Round data' file will still be available during the extension period. The 'Round data' file for a Clock Round will not be available after the end of the round. The 'Round data' file for the next Clock Round will then be made available as soon as the Auctioneer has scheduled the next Clock Round. An illustration of the contents of a 'Round data' file that will be available for download during Clock Round 4 is provided in Figure 2 of the Annex. In contrast to the 'Auction history' and 'Decision summary' files, the data for a new round is not appended to the data of a previous round. The 'Round data' file only contains information for the current (or currently scheduled) Clock Round.

### 3 'Auction history' file

#### Information contained in the 'Auction history' file

'Auction history' files including data relating to the most recent completed Clock Round will be available from when the round is closed and the round results have been approved by the Auctioneer.

To download the 'Auction history' file including the information for the most recently completed Clock Round, a Bidder can click on the 'Auction history' link on the control panel. A window will then appear asking whether the file should be opened or saved. Bidders should choose the preferred option and click "OK".

If a Bidder chooses to save the file, the resulting downloaded file will be of the form '**AuctionHistory\_X.tsv**' where **X** is the number of the most recent Clock Round for which auction data are included.

The downloadable 'Auction history' file will consist of a file with:

- a single header row describing the field; and
- a row for each service area containing tab-separated values for each field.

A list of these fields and the format of the output in each case is displayed in **Table 2** below:

### For the first Clock Round

After the results of the first Clock Round have been announced and until the results of the second Clock Round are announced, the Bidder may download the 'Auction history' file for the first round. An illustration of the contents of an 'Auction history' file that will be available for download after the first round is provided in Figure 3 of the Annex.

### For all other Clock Rounds

The auction history for a particular Clock Round after round 1 becomes available after the Auctioneer has approved the results of this round. The 'Auction history' file will remain the same until the Auctioneer has approved the results of the next Clock Round (e.g. the 'Auction history' file that becomes available after the results of round 3 are approved will be available until the Auctioneer approves the results of round 4). An illustration of the contents of an 'Auction history' file that will be available for download after round 3 is provided in Figure 4 of the Annex. The history of subsequent rounds is appended to the data from previous rounds. Hence, during a round a Bidder will be able to download the relevant information for all previous rounds.

## 4 'Decision summary' file

### Information contained in the 'Decision summary' file

'Decision summary' files including data relating to the most recent completed Clock Round will be available from when the Clock Round is closed and the round results have been approved by the Auctioneer.

To download data on its bids for all completed Clock Rounds, a Bidder can click on the 'Decision summary' link on the control panel. A window will then appear asking whether the file should be opened or saved. Bidders should choose the preferred option and click 'OK'.

If a Bidder chooses to save the file, the resulting downloaded file will be of the form '**DecisionSummary\_X.tsv**' where **X** is the number of the most recent Clock Round for which data on the Bidder's Clock Round bids are included.

The downloadable 'Decision summary' file consist of:

- a single header row describing the fields
- a row for each completed round containing tab-separated values for each field.

A list of these fields and the format of the output in each case is displayed in Table 3 below:

#### **For the first Clock Round**

After the results of the first Clock Round have been announced and until the results of the second Clock Round are announced, the Bidder may download the 'Decision summary' file for the first round. An illustration of the contents of a 'Decision summary' file that will be available for download after the first Clock Round is shown in Figure 5 of the Annex.

#### **For all other Clock Rounds**

The Decision summary file for a particular Clock Round after the first Clock Round becomes available once the Auctioneer has approved the results of this Clock Round. The information in the Decision summary file will be updated to include a subsequent round as soon as the Auctioneer has approved the results of this subsequent round. An illustration of the contents of a 'Decision summary' file that will be available for download after round 3 is shown in Figure 6 of the Annex.

The decision summary for subsequent rounds is appended to the data from previous rounds. Hence, during a round a Bidder will be able to download the relevant information for all previous rounds.
