
Subject: - Filling up the posts of Director/Deputy Secretary in the National Security Council Secretariat, New Delhi on deputation basis.

As you would be aware, the National Security Council Secretariat is a specialised unit under the direct charge of the National Security Adviser in the Prime Minister's Office. In view of the nature of the NSCS' work and in order to ensure the availability of suitable officers, the Cabinet has approved special dispensations with regard to its staffing including an extended deputation period (upto 8 years) and a special allowance of 15% of basic pay. NSCS posts do not come under the purview of the Central Staffing Scheme.

2. The NSCS presently has a number of posts at the level of Director / Deputy Secretary. Officers with an aptitude for analytical work on issues concerning internal and external security would be particularly well suited to the functioning of the NSCS.

3. I would be grateful if, as the Cadre Controlling Authority, a panel of suitable Director / Deputy Secretary / equivalent level officers who are willing to join NSCS on deputation basis is forwarded urgently to enable us to follow up on the selection process.
