### I.A. 41274/2024 (under Order XXXIX Rules 1 and 2 CPC).

31. The present suit has been filed seeking relief of permanent injunction, restraining the defendants from infringing the trademarks of the plaintiff, passing off, along with other ancillary reliefs.

32. Plaintiff is a part of the TATA Group which comprises over 100 companies across various sectors. The plaintiff was established in 1952 as Lakme Limited. In about 1998, the present name of 'TRENT LIMITED' was adopted by the plaintiff. The plaintiff is engaged in the business of operating retail fashion and lifestyle store chains such as 'WESTSIDE', 'ZUDIO', etc.

Plaintiff adopted the trademark 'ZUDIO' in the year 2015 and the 33. first store under the name of 'ZUDIO' was launched in Bengaluru in 2016 and presently operates 554 such stores in 42 cities in 27 States across India.

34. The plaintiff hosts a parent website <u>www.trentlimited.com</u> which provides information about the plaintiff's various brands, including 'ZUDIO'. The plaintiff also has a dedicated website for 'ZUDIO' brand i.e. www.zudio.com.

35. The annual sales figures and advertisement expenditure in respect of 'ZUDIO' are given in paragraph 15 of the plaint. The plaintiff has various registrations of the trademark 'ZUDIO' in various classes in India, details of which are provided in paragraph 17 of the plaint. The earliest registration in respect of the wordmark 'ZUDIO' is in the year 2015. The plaintiff has also obtained registration of its corporate name 'TRENT LIMITED' as a trademark in the various classes in India, details of which are given in paragraph 18 of the plaint. The earliest of such registrations is in the year 1998.





36. In October, 2023, the plaintiff learnt about the fake franchisee scam concerning its 'ZUDIO' brand by some unknown imposters. The plaintiff promptly took action by issuing a cautionary notice on its official website so as to alert the general public about the ongoing fraudulent activities.

37. Despite taking measures, the plaintiff kept receiving fresh complaints from people who had fallen victim to the fake ZUDIO store franchise scam by the defendant no.1.

38. The search of the plaintiff reveals that the imposters have been operating several fake and fraudulent Facebook and Instagram pages and profiles that offer fake 'ZUDIO' store franchises. It also came to notice of the plaintiff that the defendant no.1 had registered several new infringing domain names and operating fake and fraudulent websites misusing the plaintiff's trademarks 'ZUDIO' and/ or 'TRENT' as part of the domain name for offering 'ZUDIO' store franchisee.

39. The defendant no. 1 has forged and fabricated documents, misusing plaintiff's trademarks 'ZUDIO' and 'TRENT', office address, etc.

40. Based on the averments made above, the plaintiff has established its rights of being the registered proprietor of 'ZUDIO' and 'TRENT' trademarks.

41. A *prima facie* case has been made out for grant of *ad interim* injunction. Balance of convenience is in favour of the plaintiff and against the defendants. Irreparable harm and injury would be caused not only to the plaintiff but also to the public at large, since potential customers are being targeted and suffering monetary loss.

42. Consequently, till the next date of hearing, the following reliefs are granted to the plaintiff:

- i. Defendant no. 1, its employees, partners, servants, agents, representatives, and all other persons/entities in active concert or participation with them are restrained from infringing plaintiff's registered trademarks 'ZUDIO' and 'TRENT' and/or their variations, as part of their domain names, websites, mobile applications, social media handle names/ profiles credentials/ description, promotional/ business activities on digital or print media, bank accounts and/or any business papers etc. in any manner;
- ii. Defendants no. 2 to 31 (DNRs) are directed to:
  - a) lock and suspend the impugned domain names as mentioned in DOCUMENT-A, annexed with this order;
  - b) disclose the complete KYC information including payment details to the registrants of the impugned name, to the plaintiff.
- iii. Defendants no. 32 to 35 (Telecomm and ISPs) are directed to:
  - a) block the services of the telephone numbers as mentioned in DOCUMENT-B, annexed with this order;
  - b) file the complete KYC documents including sim card registration forms in this Hon'ble Court.
- iv. Defendants no. 36, 37, and 38 (MeitY, DoT, and NIXI respectively) are directed to issue necessary notifications/directions to all the telecom and internet service providers, domain name registrars in India, and social media to block, delete, and remove access to all the telephone numbers, websites, domain names, social media profile and pages, etc., which are the subject matter of the present suit;
- v. Defendants no. 39 to 47 (Banks) are directed to:
  - a) Immediately freeze the Bank Accounts as mentioned DOCUMENT- C, annexed with this order;
  - b) file the complete KYC documents, including the bank account opening forms, identity-related documents, and bank statements from the date of opening of the impugned bank accounts till the date of freezing of the impugned accounts, in this Hon'ble Court.





vi. Defendant no. 48 Meta Platforms Inc. is directed to:

- a) block access/suspend the impugned Facebook profiles and pages as mentioned in DOCUMENT-D, annexed with this order;

#### <u>Annexure</u>

Subject: Action requested to be taken by MEITY and Plantiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia sates thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider)'.

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plantiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plantiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
