Subject: Allocation of wireline-series to M/s Reliance Communication Ltd. in Delhi NCR.

Kindly refer to your letter dated 15.02.2021 requesting DoT to allow RCOM to use level 37 in NCR area of Noida/Ghazaiabd and Gurgaon/Faridabad which was surrendered by M/s RCOM.

2. In this regard, it is stated that:

- i. DoT vide its letter No. 10-13/2009-AS-III/Reliance (Part-I)/54/1565 dated 03.09.2020 has acknowledged the intimation for closure of Level '3' fixed line series by M/s Reliance Communication Ltd in LSAs Orissa, UPE, Madhya Pradesh, Himanchal Pradesh, Jammu and Kashmir, Bihar, UPW and Haryana w.e.f. 05.10.2020 and it was instructed to ensure that all the conditions specified under the respective License related to discontinuation of services to be followed.
 - ii. vide DoT letter No. 16-03/2017-AS-III/MSC/565/1034 dated 30.07.2018, levels '31' and level '32' were withdrawn in all LSAs.
 - iii. vide DoT letter No. 16-03/2017-AS-III/MSC/565/773 dated 11.09.2017 vide which levels '35' and '36' were withdrawn in all LSAs and level '37' was withdrawn in J&K, HP, Punjab, Rajasthan, Gujarat, Mumbai, Maharashtra, Karnataka, Kerala, AP, MP, Bihar, Odisha, West Bengal, Kolkata, Delhi and UP (East) circles.
3. M/s RCOM as per its letters intimated to DoT that M/s RCOM is discontinuing to provide 31', '32', '35', '36', 37 (except Tamil Nadu) in all LSAs and level '3' fixed line series in LSAs Orissa, UPE, Madhya Pradesh, Himachal Pradesh, Jammu and Kashmir, Bihar, UPW and Haryana. Accordingly, the same were withdrawn and taken on record by DoT vide above mentioned DoT letters.
4. Now, M/s RCOM has submitted that they are serving wireline enterprise customers in Noida/Ghaziabad and Gurgaon/Faridabad using the level 37. M/s RCOM has also accepted that they made an inadvertent error while communicating to DoT where they missed out

specifically mentioning usage of 37 in Delhi NCR (adjoining areas of UPW and Haryana Circles). Accordingly, M/s RCOM has requested DoT to allow using level 37 in NCR area of Noida/Ghaziabd and Gurgaon/Faridabad.

5. Keeping in view of existing wireline enterprise customers in Noida/Ghaziabad and Gurgaon/Faridabad using the level '37' of M/s RCOM, it is stated that level '37' is re-allocated to M/s RCOM in Delhi NCR area of Noida/Ghaziabad and Gurgaon/Faridabad SDCA s only.
