Subject: Amendment in License Agreement for inclusion of provision for seeking permission from Designated Authority in case of expansion of existing networks—regarding

As per the condition 6(ii) of Section-I of License Agreement for Captive VSAT Services Closed User Group Domestic Data Network using INSAT Satellite system, the Licensor reserves the right to modify at any time the terms and conditions of the License, if in the opinion of the Licensor it is necessary or expedient to do so in the interest of the general public or for the proper conduct of telegraphs or on national security consideration. In pursuance of this condition, the Licensor hereby amends/appends the following in the License Agreement for provision of Captive VSAT service:
