**ORDER**

As per intimation received from Vigilance Branch vide their letter No. /GOTH221441 dated 21.07.2022, At present, no Vigilance case/disciplinary proceedings is pending against Shri Binod Sahi (Staff No. 8533), Ex-DGM, BSNL, UP (E) However, following information has been intimated by Vigilance Branch

**Shri Binod Sahi**

1. Prosecution Sanction was issued vide order No. 9-105/2004-Vig.I dated 18/10/2005 in RC 5(A)/2003-LKO. Vide order and judgement dated 25.02.2022 passed by Hon' ble Special Judge, ACB, CBI Court No. -3 Lucknow in Criminal Case No. 20/2005, Sh. Binod Shahi has been exonerated from the charges under section 13(2) r/w 13(1)(e) of PC Act 1988.

2. CBI ACB Lucknow vide their letter dated 26.05.2022 intimated that no appeal has been filed by CBI against the order dated 25.02.2022 of Ld. Trial Court and the matter is allowed to rest by competent authority.

3. Final order issued vide No. 8-4/2006-VIG.II dated 1.7.2009 imposing a penalty of Censure against RDA No. 9-105/2004-VIG.I dated 22.12.2005 and charge memo dated 6.2.2006, in CBI case RC 5(A)/2003-LKO. As such Disciplinary proceeding was pending against the officer till 1.7.2009.

4. Final order issued vide No. 8-79/2000-VIG.II dated 06-10-2004 exonerating the officer against RDA No. 2-211/1996-VM.II dated 6.4.2000.

3. Accordingly, approval of Competent Authority is hereby conveyed for release of withheld retirement benefits viz. pension, DCRG and CVP etc. to Shri Binod Sahi (Staff No. 8533), Ex-DGM, BSNL, UP (E), retired on superannuation on 31.12.2020 (A/N).
