The DPDP Act is India's primary data protection law, establishing a framework for processing personal data and safeguarding individuals' privacy rights by outlining how one can collect, store, and use personal information. Further, the Act also provides a well-defined mechanism for Grievance Redressal.

The draft DPDP rules detail the implementation of the provisions of the Act, including specific requirements for data collection, consent, security measures, and breach notification procedures, aiming to operationalize the principles enshrined in the law. The Draft Rules will define finer details, outlining clear processes for compliance, breach reporting, grievance redressal, and enforcement.
