**ORDER**

WHEREAS, the officers of Ex-DGTD, Shri R. K. Pathak (Staff no. 76024) and Smt. Sangeeta Chugh (Staff no.76025) were granted NFU in HAG vide this office order 317-06/2021-STG-III dated 18.02.2022 after considering their request.

AND WHEREAS, the NFU/NFSG granted to the above officers has been re-examined in the light of clarification received from DoPT vide OM dated 07.08.2023. It is observed that the ex-DGTD officers are not part of an Organized Group 'A' Service (OGAS) and hence not eligible for the benefits meant for OGAS. The scheme of NFU came only in 2009 and the OMs on the subject clearly mentions the criteria for extension of NFU. Accordingly, the NFU/NFSG granted to the officers of ex-DGTD is not in accordance with DoPT instructions.

Therefore, the President is pleased to cancel the order No 317-06/2021-STG-III dated 18.02.2022 issued in respect of the following officers of Ex-DGTD for granting NFU in HAG-
