(1) Disciplinary inquiry vide Memorandum No. 100-18/2021-STG-I dated 25.10.2021 initiated by Cadre Controlling Unit against Sh. Jyoti Bhushan Prasad under Rule 14 of CCS(CCA), Rules 1965 against Sh. J B Prasad on the ground of administrative lapses.

(2) Final order issued by cadre controlling unit vide No. 100-18/2021-STG-I dated 20.11.2023 wherein charges against Sh. Jyoti Bhushan Prasad has been dropped.
