ORDER

WHEREAS, Shri Chinthala Ramesh (Staff No. 60039), JTO while functioning in the office of DDG, TERM-Tamil Nadu, Coimbatore {now known as DDG(C), Coimbatore, Tamil Nadu LSA} proceeded on 19 days of Earned Leave with effect from 06.02.2017. Subsequently, he sent an application for grant of medical leave with effect from 04.03.2017 to 03.05.2017 and remained continuously absent from duty thereafter.

AND WHEREAS, several reminders were sent to Shri Chinthala Ramesh including final show because notice dated 21.06.2017 conveying him that if he fails to join the office by 28.06.2017, disciplinary action will be initiated against him for wilful absence from duty which renders a Government Servant liable for disciplinary action under CCS(CCA), Rules 1965. However, Shri Chinthala Ramesh did not join the duty.

AND WHEREAS, an inquiry was instituted against Shri Chinthala Ramesh vide a charge Memorandum dated 31.12.2018. He was extended sufficient opportunity to attend the inquiry proceedings. Shri Chinthala Ramesh vide his letter dated 27.08.2019 admitted that while he was called to attend Inquiry proceedings on 18.07.2019, 06.08.2019 and 26.08.2019, he was unable to attend the same as has requested for resignation because of his personal problems.

AND WHEREAS, Shri Chinthala Ramesh failed to attend the disciplinary proceedings. Ultimately, the inquiry proceeding was conducted on "ex-parte" basis and the IO concluded that the charge of "having failed to maintain devotion to duty" stand proved.

AND WHEREAS, Shri Chinthala Ramesh sent a representation dated 04.09.2019 in response to the brief of the Presenting Officer in which he stated that "he was unable to continue his services to the Department because of his personal health and family problems".

AND WHEREAS, a copy of the IO's findings in the inquiry report was delivered at his registered address of Shri Chinthala Ramesh on 27.01.2020 by

Director(Compliance), TN LSA and on 30.01.2020, another copy was delivered through India Post for making representation, if any, against the IO's finding. However, Shri Chinthala Ramesh did not prefer any written explanation against the inquiry report within stipulated time.

AND WHEREAS, it is considered that the conduct of Shri Chinthala Ramesh, warrants the imposition of a major penalty.

NOW, THEREFORE, in exercise of the powers conferred by Rule 15 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, the Competent Authority, Adviser(O), hereby removes the said Shri Chinthala Ramesh, JTO from service with immediate effect.

The receipt of the order shall be acknowledged by Shri Chinthala Ramesh.
