The matter has been examined by this Department in consultation with Department of Expenditure and it has been decided that apart from existing Rajdhani, Shatabdi and Duronto trains, travel by **Tejas Express**, **Vande Bharat Express & Humsafar Express** trains under LTC as per the entitlement of the Government employees, has now been allowed, as under:-
