

Dear Shri Sir,

I have, through my various letters as well my personal interactions, requested you to consider seconding one or two of your service officers to the Institute. As an important stakeholder, I have been looking forward to the involvement of participating services in running the Institute for achieving the objectives for which it was established by the participating services and the Government of India.

You would appreciate that participation of the service officers in planning, organising and executing various training programmes which are meant for Officer Trainees and other Government Officers would go a long way in improving the quality of all the programmes of the Institute. It will also help in understanding the training needs of various departments of government so that the training programmes and interventions can be suitably designed and executed.

In the 53rd Meeting of the Board of Governors held in November, 2020 the Chairman of the Governing Body and Secretary (Expenditure) had appealed to all participating services to consider sending atleast one officer from each service to AJNIFM. He had even followed it up with a D.O. letter dated 22nd December, 2020 addressed to heads of participating services. I would like to inform you that, except for an officer from Indian Cost Accounts Service, the Institute has no one else from any of the participating services at present. The Institute has vacancy position at all levels for the officers of participating services. The details of number of years of service requirement for each position are:

Professor / Joint Director	16 Years
Associate Professor (SG) / Senior Deputy Director	12 Years
Associate Professor/Deputy Director	7 Years
Assistant Professor / Senior Assistant Director	5 Years

24th October, 2017. Besides transport facility is also extended as per their admissibility prevailing in the Government of India and the Central Secretariat. Housing facility is also available in the Institute. Further, in order to address the concern of waiving-off of the cooling period, a view was taken with the concurrence of Secretary (Expenditure) that Cadre Controlling Authority of the participating services may consider seconding their officers as part of their normal deployment and not outside the normal field of deployment. I have written to you in this regard vide my D.O. letter dated 26.02.2021.


While I appreciate that you may have certain constraints to consider deploying your middle management level officers because of vacancy situation, I would, however, urge you to kindly consider that as a participating service and a Member of Board of Governors you are an important stakeholder and this Institute is as much yours as the training institute of your department. Your service members have contributed immensely in the past and I look forward to your continued contribution and support in the future as well.

I would therefore request you to kindly give due publicity among your officers and consider forwarding names of the willing and suitable officers who have flair for academic/teaching/ training activities with requisite qualifications. The applications along with ACR dossiers of last five years may kindly be sent to us in the earliest.

I hope to have your kind understanding and consideration in the matter.
