Subject: Amendment to the Eligibility Conditions for the post of Telecom Assistant (TA) and Extension of the Last Date for Submission of Applications – Reg.

References:

- Vacancy Circular No. 30/223/UPW/LSA/LDC-TA/24-25 dated 24.02.2025, inviting applications for the posts of Lower Division Clerk (LDC) and Telecom Assistant (TA) on deputation basis.
- Office Order No. 30-64/UPW/LSA/TransferPosting/24-25-Part(2) dated 24.03.2025, regarding the extension of the last date for submission of applications for the Group 'C' posts of LDC and TA.

In continuation of the vacancy circular and subsequent office order cited above, a corrigendum is being issued due to amendments in the Recruitment Rules for the post of **Telecom Assistant (TA)**, as notified vide **G.S.R. 187(E) dated 24.03.2025**. The details are as follows:

1. Amended Eligibility Conditions for the Post of Telecom Assistant (TA):

The entry under Sr. No. 4 (Eligibility Condition) of the vacancy circular dated 24.02.2025 includes a table outlining the eligibility details. Within this table, under S. No. 1 for the post of Telecom Assistant (TA), the subheading "Educational Qualification (a) Essential" has been revised and shall now be read as follows:

Educational Qualification (a) Essential:

 Minimum three years Engineering Diploma in Telecommunications or Electronics or Electrical or Electronics and Communications or Computer Science or Information Technology or Cyber Security and Big Data Analysis or Internet of Things (IoT) or Instrumentation from a recognized Institute or University; OR Bachelor of Science in Electronics or Electronics and Communication or Computer Science or Information Technology from a recognized University or Institute.

Note: The required qualifications may be relaxed at the discretion of the Staff Selection Commission or the Competent Authority in cases where candidates are otherwise well qualified.

2. Revised Last Date for Submission of Applications:

To ensure wider participation, the last date for submission of applications in the prescribed format (as per the vacancy circular dated 24.02.2025) through the proper channel is hereby extended to **06.05.2025**.

3. Other Terms and Conditions:

- All other terms and conditions, including age limit, quantification etc as stipulated in the original Vacancy Circular No. 30/223/UPW/LSA/LDC-TA/24-25 dated 24.02.2025, shall remain unchanged.
- Applications already received in response to the original vacancy circular shall remain valid. Candidates who have already applied do not need to submit a fresh application, as their original applications will be considered.
