**Subject:** Submission of Immovable Property Returns for the year 2013 (as on 01.01.2014).

In terms of the Rule 15 of CCS (Conduct) Rules, every Group 'A' and 'B' officer shall submit a return of immovable property in the month of January every year. Therefore, it is requested that the Annual Immovable property returns for the year 2013 (as on 01.01.2014) in respect of all Group 'B' Non-Gazetted officers of Indian Radio Regulatory Service (formerly WPC/WMO), Department of Telecom may be furnished in prescribed profoma (enclosed) by 31.01.2014.

2. The usage of phrases "no change" or "no addition" or "as in the previous year" should be avoided and full particulars of the immovable property inherited/owned/acquired or held should be furnished. It is further informed that the status of furnishing of IPR is to be mentioned for seeking Vigilance Clearance, therefore, it is requested to advise all the officers to submit their IPRs by 31.01.2014.
