The undersigned is directed to forward herewith a copy of Training Division, DOPT's letter No.12037/40/2013-FTC dated 25^{th} September, 2013 on the above mentioned subject. The officers are advised to go through this circular in detail. The list of long-term programmes and short term programmes proposed to be conducted during the FY 2014-15 are indicated in Annexure-A.

2. The applications for both long-term and short-term training programmes must be accompanied by the ACR/PAR grading pertaining to the last five years. To be eligible for consideration for a long-term programme, the officer should have at least 'Very Good' grading in his/her ACRs pertaining to the past 5 years. Applications should be complete in all respects. Applicant should be clear from Vigilance angle.

3. The application form (Annexure-I) for long-term and short-term foreign training as well as forwarding form (Annexure-II) meant for filling by the Nodal Officers designated by each Ministry/Department and State Governments are available in DOPT's website at http://persmin.nic.in/dfft. It must be ensured that the application form for both categories of programmes (long -term and short-term) must be filled in online by the officers after which the same will be automatically forwarded by the system to their respective controlling authorities. The Nodal officers will then fill in the requisite details in Annexure-II and send the same along with application form (Annexure-I) of the officer 'online'. It may be noted that there is no requirement of sending these documents by post. The necessary steps that the Nodal Officers are required to take for forwarding the application forms through 'online' mode are detailed at Annexure-B. The last date for receipt of applications, as per procedure to Training Division, DOPT is 31st December, 2013.

4. However, the applications of officers interested in the short-term training programme 'Managing Global Goverance' to be conducted by GIZ, Germany, must be forwarded to Training Division, DOPT latest by 30th November, 2013, as the nominations for this specific programme are required to be forwarded by DOPT to the concerned institute by 31st December, 2013.
