**OFFICE MEMORANDUM**

**Subject: Matters related to Delhi Legislative Assembly Elections – 2025.**

The undersigned is directed to say that in connection with the above-mentioned subject, all the Cadre Controlling Authorities of DoT, HQ are required to populate the data of all the Officer/Officials [up to the grade pay of Rs. 8700/- (pre-revised)/ Level – 13 (revised)] under their respective administrative control on the concerned web-portal (<https://ceo.delhi.gov.in/>) of Chief Election Officer, Delhi.

2. Now, it has been decided to keep up to 50% staff (upper limit) [up to the grade pay of Rs. 8700/- (pre-revised)/ Level-13 (revised)] from each cadre in DoT, HQ among their in-position strength (not in sanctioned strength) reserved and not to be ordinarily deputed for Election Duty, for enabling functioning of the organization provided that the Officers/Officials [up to the grade pay of Rs. 8700/- (pre-revised)/ Level-13 (revised)] attached to the following offices of DoT, HQ are fully exempted from Election Duty: -

- a. O/o Hon'ble MoC.
- b. O/o Hon'ble MoSC.
- c. O/o Secretary(T)/Member(S)/Member(T)/Member(F)/AS(T)/Administrator (USOF)/Officers of Central Staffing Scheme.

3. It is, therefore, requested that all the Cadre Controlling Authorities in DoT, HQ may please record in-position strength of their respective cadre(s) after deducting the 50% staff as mentioned at Para-2 above on the web-portal (<https://ceo.delhi.gov.in/>) of Chief Election Officer, New Delhi. The User-ID and Password for populating the requisite data has been provided/is being provided to Sub-Nodal Officers of DoT designated for the purpose.
