**G.S.R. ....:-** In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Indian Radio Regulatory (Group 'A') Service Rules, 2015, namely:

**1. Short title and commencement:-** (1) These rules may be called the Indian Radio Regulatory (Group 'A') Service (Amendment) Rules, 2024.

(2) They shall come into force on the date of their publication in the Official Gazette.

**2.** In the Indian Radio Regulatory (Group 'A') Service Rules, 2015,-

**(1)** SCHEDULE-I shall be replaced by the following, namely:

(2) In SCHEDULE III, for the entry under Column relating to feeder grade for promotion and eligibility conditions of Senior Deputy Wireless Adviser/Senior Deputy Director occurring at Sr. No. 3, shall be replaced by the following:

**“Promotion**

- (i) Officers with Thirteen years’ of regular Group ‘A’ posts in the Service out of which at least four years’ of regular service should be in Senior Time Scale Level-11 (Rs. 67,700-2,08,700) including the regular service, if any, rendered in the Non-Functional Selection Grade (NFSG) in the Leve-12 (Rs. 78,800-2,09,200); or

Senior Time Scale Level-11 (Rs. 67,700-2,08,700) officers with nine years’ of regular service in the grade including the regular service, if any, rendered in the Non-Functional Selection Grade (NFSG) in the Leve-12 (Rs. 78,800-2,09,200),

and

- (ii) Having educational qualification prescribed for direct recruitment at Junior Time Scale grade.

(3) In SCHEDULE III, the entry against S. No. 4 in respect of Deputy Wireless Adviser/ Deputy Director, shall be replaced by the following:
