- (i) Final Order was issued vide No 8-6/2013-Vig.II dated 28.09.2016 imposing a penalty of reduction to a lower stage in the time scale of pay by two stages for the period upto 15.03.2017 with the direction that he will not earn increments during the period of such reduction and on the expiry of such period, the reduction will not have the effect of postponing the future increments of pay against RDA No. 5-2/2010-VM.III dated 26.2.2013.
- (ii) FO issued vide no.8-26/2016-Vig.II dtd.09.08.2019 imposing penalty for withholding of 5% of his monthly pension otherwise admissible to him for a period of one year against RDA no 5-2/CG/2010-VM (pt-V) dtd. 29.03.2017.
