The Government Accounting Standards Advisory Board was set up (2002) to establish and improve standards of government accounting and financial reporting, and to enhance accountability mechanisms.

2. The Comptroller and Auditor General of India had established a GASAB Secretariat in this office, by drawing resources from various accounting services. The multi-disciplinary inputs would help dovetail various accounting perspectives, thereby providing a wholesome approach to development of the standards.

3. Ms. Vandana Gupta, IP&TAFS (1990), who was on deputation as Pr. Director (GASAB), has reverted back to her parent cadre on 09.03.2022.

4. The post of Pr. Director (GASAB) deals with crucial matters relating to the GASAB Secretariat and, thus, cannot be left vacant for a long period. Also, the GASAB Secretariat has a number of initiatives lined up which require full strength for proper execution.

It is, therefore, requested to kindly forward a panel of IP&TAFS officers in the Senior Administrative Grade (Pay level 14), alongwith bio-data and attested copies of APARs for the last available five years and vigilance/cadre clearance, for consideration for appointment as Principal Director (SAG level) in Government Accounting Standards Advisory Board (GASAB) Secretariat in this office, on full time deputation basis.
