Subject: Offer of appointment to the post of Junior Telecom Officer (JTO) in the Department of Telecommunications on the basis of the results of Engineering Services Examination, 2019 (Reserve List)– regarding

Sir,

On the basis of the results of the Engineering Services Examination-2019 held by Union Public Service, the Competent Authority is pleased to offer you appointment to the post of Junior Telecom Officer [TES Group 'B'; Gazetted post] in the Level 07 in the scale of pay of Rs 44900-142400 + allowances in pay matrix of 7th Central Pay Commission in the Department of Telecommunications (DoT), Ministry of Communications, New Delhi on provisional basis.

2.1. You will be on probation for a period of two years from the date of appointment in the Service. The Competent Authority may extend the period of probation in accordance with the orders and instruction issued by the Government in this behalf from time to time. On completion of the period of probation or an extension thereof, you shall, if considered fit for the service, be considered for confirmation.

2.2. If during the period of probation or any extension thereof, as the case may be, the Competent Authority is of the opinion that you are not fit for service, it may terminate your Service, or pass such orders as it may deem fit.

2.3. During the period of probation or any extension of thereof, you are required to undergo such training and instructions and to pass such examination and tests (including examination in Hindi) as prescribed by the Competent Authority from time to time.

2.4. As regards matters relating to probation, if not covered by these rules, the members of the Service shall be governed by the instructions issued from time to time by Government in this regard.

3.1 The offer of appointment of the Candidates is provisional and subject to followings -

(a). **The class/caste/tribe certificates are being verified, through proper channels, and if the verification reveals that the claim to belong to Other Backward Classes/Scheduled Castes/Scheduled Tribes, as the case may be, is false, your services will be terminated forthwith without assigning any reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates. If at any stage, it is found that any Certificate/Document/testimonial etc. including caste certificate, as furnished by the candidate and having a bearing on his/her eligibility is not in order, his/her appointment shall be cancelled forthwith without prejudice to any punitive action under the relevant rules.**

(b). **Verification of Character & Antecedents is being carried out from the concerned District Authorities. If anything is found adverse against you on such verification, your services will be terminated forthwith without assigning any reasons**

3.2 It may be stated that no person –

(a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person

shall be eligible for appointment to the Service, provided that the Central Government Competent Authority may, if satisfied, that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

4.1 The officers appointed to the Service shall be liable to serve anywhere in or outside India.

4.2 It may also be noted that on your appointment to the Service, if so required, you shall be liable to serve in the Territorial Army subject to the provisions of Section 6(A) of the Territorial Army Act, 1948 (56 of 1948) and the rules made there-under. Provided that such officer shall not ordinarily be required to serve as aforesaid if he/she has attained the age of forty (40) years

5. In accordance with Ministry of Finance, Department of Economic Affairs Notification No.5/7/2003-ECB&PR dated 22.12.2003, new entrants to the Central Government service, who have joined on or after 01.01.2004 are covered for pension under the new restructured defined contribution pension system introduced by the Government of India vide OM No. 1 (7)(2)/2003/ TA/11 dated 07.01.2004 and No. 1 (7)(2)/2003/TA/67-74 dated 04.02.2004, and in accordance of which you will be required to furnish particulars as in the enclosed proforma, Annexure-I

6. In respect of matters not specified above, you will be governed by the relevant rules and orders of the Government in force from time to time generally applicable to the officers of the Central Government.

7.1. If you accept the offer of appointment on the said terms and conditions of the Service, you shall report to the DoT office as indicated against your name is **Annexure -VII** of this letter on **15.06.2021**.

7.2 In case, a Candidate fails to report at the allotted office of posting by 30.06.2021, his candidature will be treated as cancelled and no further communication will be entertained.


7.3 Further, I am directed to forward herewith a copy of blank attestation form. The Candidates shall submit seven (07) copies of the same, in original duly filled-in along with a copy of Aadhar Card, to Dir(Admin) in the allotted DoT office (**as per Annexure-VII**) for verification of their character and antecedents. Dir(Admin) of the concerned unit of DoT shall forward 6 copies of duly filled (in all aspects) Attestation Forms to this office within 7 days of reporting of the candidates.

7.3 Candidates shall further submit following duly filled-in documents to the reporting office at the time of their reporting for joining. Joining will not be accepted without furnishing of these information.
