- 2. This Section's Order No. A-22012/02/2016-Admn.II dated 24.10.2016 which was issued earlier for vacancy year 2016-17 stands modified to the extents of promotion mentioned in the above list.
- 2.1. The Officers at Sl. No. 1-7 and Sl. No. 13-16, who have already joined as Engineer based on Order dated 24.10.2016, are not required to join the post again and their date of joining will remain same as earlier. - 4. As stated in the aforementioned letter dated 11.12.2023 of UPSC, attention is also invited towards instructions contained in para 6.4.4 of the DoPT's OM No. 22011/5/86-Estt.(D) dated 10.04.1989, which provide that the promotions will have only prospective effect even in cases where the vacancies relate to earlier year(s). Hence, this Order will not have any effect on Officers who have already retired from Government Service.
- 5. Further, since the Jarnail Singh batch of cases is pending in the Supreme Court of India, this promotion order is subject to further orders that may be passed by the Hon'ble Supreme Court.
