The undersigned is directed to refer to DoP&T's letter F.No.11013/3/2014-Estt(A) dated 23.7.2014 on the subject mentioned above and to say that the Government has notified the Public Servants(Furnishing of Information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Returns) Rules, 2014 under the Lokpal and Lokayuktas Act 2013 on 14.7.2014. The same is available at the website of DoP&T(www.persmin.nic.in-DOPT-LOKPAL).

- 2. As per the said Act and the Rules framed there under, every public servant is now required to file declaration, information or return, as the case may be, regarding his assets and liabilities as on 31<sup>st</sup> March every year, to the competent authority, on or before the 31<sup>st</sup> July of that year. Every public servant is also required to file revised declarations, information or return as the case may be, annual returns as on the 1<sup>st</sup> August, 2014, to be competent authority on or before, 15<sup>th</sup> September, 2014.

It is requested to bring the provisions of the public servants(Furnishing of Information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filling Returns) Rules, 2014 to the notice of all ITS officers/TES Group 'B'/GCS Gr.'B' & 'C' officers(un-absorbed) under the Administrative control of BSNL/MTNL/BBNL/ TEC/ TRAI/TCIL.
- 4. All ITS officers/TES Group 'B'/GCS Gr.'B' & 'C' officers are requested to submit the hard copy of declarations, information and returns in the prescribed proforma(Appendix -I/Form No.I, II, III IV) to their respective controlling authority by 05.9.2014.
- 5. BSNL/MTNL/BBNL/TEC/TRAI/TCIL are requested to compile the declarations, information and returns received from ITS officers/TES Group 'B'/GCS Gr.'B' & 'C' officers and forward the same to the undersigned by 15.9.2014 in the enclosed proforma in Hard Copy as well as Soft Copy through e-mail ID "deonath.sah@nic.in"
