ORDER

Subject:- Review DPC – Promotion to the grade of Superintending Engineer(Civil) in the P&T Building Works Service under the Department of Telecommunications in compliance with different CAT Orders.

In compliance of the order of Hon'ble CAT Madras bench in OA No. 161/2001 as upheld by the High Court of judicature at Madras in WP No. 17603 of 2001, order dated 6.1.2011 of the Hon'ble CAT Patna bench in OA No 10/2010 filed by Shri M.S. Siddique & others, order dated 21.7.2011 of the Hon'ble CAT Allahabad bench in OA No. 1304 of 2010 filed by Shri P.K. Jain & others, order dated 20.10.2011 of the Hon'ble CAT, Ernakulam bench in OA No. 734/2009 filed by Shri P. Kailasam & OA No. 599 of 2010 filed by Shri M. Raithaswamy and interim order dated 21.11.2011 of the Hon'ble CAT(PB), New Delhi in OA No. 3508 of 2009 filed by Shri A.K.
