Minutes of Meeting dated 16th May 2012: IPv6 implementation in Central Govt. Dept. - Progress and Review

Proceeding and Points Discussed:

Shri N RAM, Dir (NT) welcomed all participants. Shri R M Agrawal DDG (NT) said in the opening address that IPv6 offers a number of advantages in addition to huge address space. we need to ensure 100% migration of all the websites of the Central Government Departments. Some organisations like BHEL, BARC, M/o Urban Development etc. have done good works in migration, Projects and Case Studies &Tests. He further said that very few department participated in the meeting, despite regular persuasion from this office and only few have submitted IPv6 activity sheet, in spite of a D O letter by Secretary (T) to all Secretary, Govt of India (List of Departments who have not submitted activity sheet is attached at Annexure -2 and List of Departments from where both activity sheet and nomination of Nodal officer have Not been received is attached at Annexure -3)

- 2. Shri N Ram, Dir (NT) gave presentation regarding Government of India Guidelines, IPv6 implementation status, Activity Sheet etc of Central Government Organisations. The Activity Sheets submission by Central Government Dept./Organisation was discussed.
- 3. Participants discussed auditing of Equipments and it was clarified that the auditing of equipments was the identification and decision upon the equipment for IPv6 migration. It was also suitably clarified that IPv6 migration is not synonymous to Hardware replacement. Hardware upgradation might be a separate routine activity in the Department/Organisation.
- 4. While discussing IP address allocation policy, It was decided that if hardware is ready for IPv6 service, NIC should allocate IPv6 addresses. Shri R S Mani, Sr. Tech. Director, NIC, said that the NIC would allocate address space to each department/organisation wherever it is serving. It has already allocated IPv6 address for SWAN. DDG (NT) said that the NIC should make a plan in this regard and update the DoT also in this regard.
- 5. Col R S Kang, Dir (ICT), MoD, said that in case of defence organisation, there was need to find ways to define the requirement of IPv6 Address Space. DDG (NT) said that we should always take care of future requirement. A template plan may be given to NIR. As time passes, there are chances of getting lower address space. If required, we can have separate meeting in this regard.
- 6. Activity Sheet and progress of IPv6 migration activity was discussed with each nodal officer of the Dept/ Organisation.

- 7. Shri Manish Garg, DGM, BHEL presented their case for migration to IPv6. He said that the organisation followed the activity sheet provided by the DoT. Their scope of work were limited to router, firewall, and network equipments. All new equipment purchase were essentially specified with IPv6 compliance. the learning for the IPv6 migration were done through DoT websites, TEC Websites and youtube tutorials. At different places, The service providers were pursued for extending IPv6 service to the organisation.
- 8. Shri R S Mundada and Shri Sunil Mathur of BARC presented projects being carried out at BARC, Mumbai and BARC Centre at Indore. Fire walls and Security relates tests are being carried out at the BARC.
- 9. Representatives of Empanelled Consultant presented their activity and scope of work. TCIL, TechMahindra NIT Hamirpur, TCS, CDOT, HCL Infosystems, Neosixth Technologies appraised all the participants of their consultancy.
- 10. Shri R S Mani, Sr. Tech. Director, NIC, said that the NIC was working to migrate all the websites of Government Organisation on dual stack. Some of the websites were migrated and hopefully all remaining would be migrated in next three months.

Meeting ended with vote of thanks.
