Officers belonging to Indian Police Service (IPS), Indian Forest Service (IFoS) and officers belonging to various Organized Central Group "A" Services are to be considered for empanelment for appointment at the level of Secretary and Additional Secretary in the Government of India. In addition, officers fulfilling the following criteria only would be considered for empanelment:

- Year of examination is not later than 1991 (i.e. 1992 batch) for Secretary level and 1997 i. (i.e. 1998 batch) for Additional Secretary level;
- Officer should have been empaneled at Additional Secretary level (for empanelment at ii. Secretary Level) and at Joint Secretary level (for empanelment at Additional Secretary level);
- Officer should have at least 3 years' experience under Central staffing Scheme at the level iii. of Deputy Secretary & above; and
- Officer should have at least one-year's residual service as on 01.01.2025. iv.

The reference date for determining the eligibility shall be 01.01.2025.

The nominations in respect of eligible officers belonging to Service(s) under your -3. administrative control may please be sent to this Secretariat in the enclosed formats latest by 31.05.2025.
