2. Since then, the whole process has further been simplified. Now, the entire licensing process has been made paperless and on "Single Scrutiny" basis, in respect of the following categories of licences:

- 3. With the launch of Single Scrutiny Workflow, initially, all the requisite data will be captured at one time. After scrutiny by the concerned section/group, Letter of Intent (LOI) will be issued. Subsequent to the issue of LOI, all the other processes viz, Decision Letter, Import Clearance, SACFA Clearance and Wireless Operating Licence, wherever applicable are applicant driven and auto-generated without any further scrutiny. These approvals/licenses can be downloaded from the portal by the applicant.
- 4. The detailed user manual on this subject matter is available on the Saralsanchar portal. For any query, concerned Groups or Regional Licencing Offices of WPC Wing may be contacted.
- 5. All the licensing divisions/offices of WPC Wing, including RLOs etc. are required to use the above facility to the full extent, with a view to further improve the overall efficiency and ease-of-doing business environment.
