**Subject: NOCC charges for use of space segment -regarding**

In partial modification of DoT letter No. 59-146(2)/2003-SAT dated 29.10.2003 (enclosed as Annexure), the competent authority has decided to remove the NOCC charges for the telecom service licensees, for the use of space segment.

2. Accordingly, there shall be no NOCC charges for use of space segment for all DoT licensees for Commercial/ Captive VSAT Services, GMPCS, NLD and other telecom licensees having Unified License/standalone license. This order shall be effective from 1<sup>st</sup> April 2022.
3. All the other terms and conditions of the DoT letter No. 59-146(2)/2003-SAT dated 29.10.2003 will remain unchanged.

Sub: Fixation of NOCC charges for Operational Control/Coordination and Monitoring of INSAT system.


Ref: This office letter No. 59-146/2001-SAT dated 19.06.2003

The matter regarding fixation of NOCC charges on flat rate system was under examination in DoT and in supersession of decision communicated vide letter under reference, following decisions are communicated:

1. NOCC charges shall be fixed at Rs. 21 lakhs per transponder (36 MHz) per annum irrespective of frequency band of operation and satellite.
2. NOCC charges for a part of a transponder shall be calculated on pro-rata basis.
3. NOCC charges shall be payable by all the users of INSAT/Foreign Satellite (Telecom, TV, Broad-casting) and shall be claimed by NOCC directly from the Users before giving NOCC clearance/approval for the new/additional space segment allocations, thereafter it shall be claimed in advance.
4. The same procedure shall be followed for the VSAT operators and TV/Broadcasting operators working in India on Foreign satellites.

Necessary action may kindly be taken accordingly.
