I. COMPANY PROFILE

Bharat Sanchar Nigam Ltd. Its Registered and Corporate offices are at New Delhi.

The shareholding of the Government of India in the Company is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director(Consumer Mobility) is a member of the Board of Directors and reports to Chairman and Managing Director. He is responsible for drawing up business plans for introducing new telecom services, technology forecasting, planning for switching and transmission equipment, long distance network planning and coordination and material procurement activities. He is responsible for working out long term business plans for the company.
