Objectives for the award process

- Award spectrum transparently and fairly
- Promote efficient use of spectrum
 - Stimulate competition
 - Encourage roll-out
- Ensure effective competition for spectrum
- Generate revenue for the public purse



What is being awarded

- 3G auction
 - 3 or 4 blocks of 2x5MHz in the 2.1GHz band
 - 22 service areas
- BWA auction
 - 2 blocks of 20MHz in the 2.3GHz band
 - 22 service areas
- BSNL and MTNL received spectrum outside auction process, but at a market price to be determined by the auction

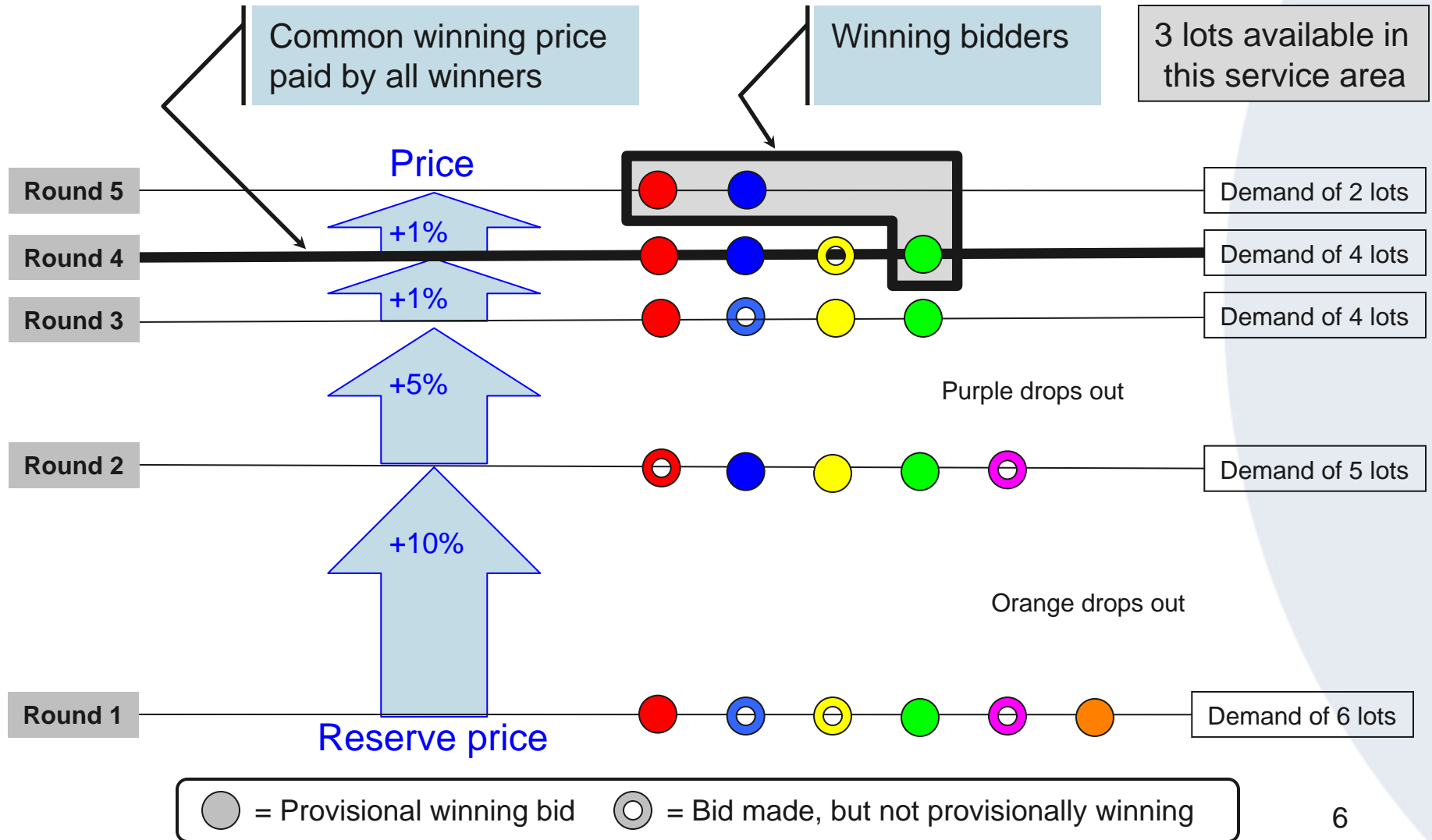


Auction format

- **Simultaneous** auction of all 22 service areas
- **Multiple-round clock** auction
 - Proceeds through multiple open rounds
 - Bidders accept/reject the price posted each round
 - Predatory jump bidding not possible
- At the end of each round, **provisional winners** are declared
 - Behavioural economics suggests benefits for revenue
 - Allows features to discourage collusion
 - Reduces unsold lot risks for the Government



The clock round structure for one service area





Activity rules

- Activity rule forces bidders to make bids to preserve rights to bid in subsequent rounds
 - Prevents bidders waiting until the end of the auction to bid on their target service areas
 - Promotes price discovery – clock prices tend towards market prices and bidders can update business cases
- Activity rule implemented through an “eligibility point” system



Eligibility point system

- Each service area given a points weighting
- A bidder cannot bid for more service areas than its **eligibility points** allow
 - Bidder's Earnest Money Deposit determines its eligibility to bid in the first round
 - In subsequent rounds, eligibility points determined by bidding activity in the **previous** round
- Bidding **activity** determined by new bids, plus any provisional winning bids held through the round
- Bidders do not initially have to be active on all their target services areas, but the **activity requirement** tightens in stages (80%, 90%, 100%)

End of the auction

- Simultaneous auction, so **all** service areas remain in play until the end
- Auction ends when demand is no more than the number of available lots in **every** service area ...
- ... and the activity requirement is 100% (i.e. bidders must bid for all their targets)



Pro-competitive features of the rules

- Bidders only told total demand in each service area, not who is bidding for what
- Auctioneer will announce new, higher clock price and invite new bids even when the number of current bids at the clock price is equal to the number of lots available
- These measures are aimed at frustrating coordinated outcomes



e-auction implementation

- Auction to be run online over a secure web-site from 9th April 2010
- Mock auction run on 5th April 2010
- Conduct of auction specified by rules in the NIA, so administrator's discretion limited to:
 - round scheduling; and
 - increasing the activity requirement.
- Price increments are set by rules in the NIA
- All bid data will be made public after the auction has completed

Login and security process

- EAS runs on a secure website
- Access to the server is authenticated by means of digital certificates
- Once Bidders have accessed their bidder-specific website, they will be required to enter login credentials
- Bidders can have only one computer logged in at any one time
- All bidders have successfully accessed the EAS in the mock auction

Checking and submitting bids

- Bid submission is a two-stage **check-submit** process:
 - Bid first **checked** for compliance with the auction rules
 - activity rules
 - Earnest Money Deposit requirements
 - If the bid is valid, the Bidder may then **submit** it
- Invalid bids cannot be submitted – the Bidder needs to return to the bid form to amend the bid
- Once a bid has been submitted, it cannot be modified or withdrawn
