

Sir,

*It has been observed that Each & Every Ministry is not following the Constitution of India & their Act for their own interest. It has created the greatest disaster of corruption in each corner of India and generates the three Major Problems i.e. (1) Not control on price rising (ii) corruption (iii) unemployment. It was noticed that ever point generated due to wrongly and incapable Contract made by you and your Department. In your Contracts, you have been failed all your Act. You & your Department have been / are implemented /implementing in their own Act as per their views in Contract. Although, you and your Department has the administrative powers in respect of implementation of Act, but it is not implemented in right way and use the Contract for implementation of Schemes and Utilization of Plan and Non Plan Grant. Now, I have planned to file a Public Interest Litigation (PIL) against role of Contract Act / Agreement and whether it overrides all the Act i.e. Contract Act vs. All Act. The information provided may be treated as final and treated as Department & Your Govt. decision for PIL. Ist Appeal & Second appeal will not be filed. If you will not provide information within time period of 30 days or 35 days (in case of transfer) that will be treated as Department has no information and hide the information in this regard. Accordingly, you will pay the penalty as per RTI Act for supply of delay information before submission your representation as defaulter and otherwise you will be treated as defaulter and submit fake and manipulated documents.*

*Sought informations are given below:*

- (a) How many schemes or Utilization of Plan and Non Plan Grant have been / are implemented / implementing and executed / executing by Govt. of India / States Govt. / UT Govt. since last 15 years? Please provide the details.*
- (b) How many staff have worked / are working in your schemes since last 15 years under contract? Please provide the sample copy of agreement. If your Department has changed any agreement please provide the separate sample copy of each contract.*

✓ (c) How may staff have been / are employed / working through contract agencies since last 15 years? In this respect sample copy of agreement may be provided.

✓ (d) How much agreement (any nature) have been made by your Department with Contractor regarding execution since last 15 years? Please provide the copy of Agreement.

(e) If you have taken approval from cabinet or from others in respect of non implementation of Act in parallel of any kind of execution. Please provide the copy of cabinet /others approval.

(f) Has law Ministry given the administrative approval for not implementation of Act. Please provide the copy of approval.

(g) Is it necessary that Act failed / ignored in each agreement for implementation? Please provide the copy along with justification.

(h) Your Department has made the payment to Contractor against bills as per agreement. Although, they have not fulfill the all relevant formalities in respect of the Act. It proves you have diverted your own liabilities by Contract. If, you have taken necessary action to implementation of Act. Please provide the copy.

Now, you are requested to please provide the accurate, relevant & authentic information with supporting documents.


