APPELLATE ORDER ON APPEAL DATED 17.01.2018 FILED BY MS. SUMITA PURKAYASTHA

I, Abhay Kumar Singh, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 17.01.2018 filed by Ms. Sumita Purkayastha:-

Facts of the case:-

1. Ms. Sumita Purkayastha sought the information under RTI Act, 2005 vide her application dated 11.12.2017.
2. The grounds of Appeal are as under :-

2.1. Reply of CPIO which has been annexed contravenes Article 7 of the RTI Act 2005. Hence, requested information may be furnished forthwith as per above Act.

3. **Decision on the Appeal**

Regarding Point No.1:- CPIO vide her letter dated 02.01.2018 has intimated to the Applicant-Appellant that "information along with documents for the non notification of RR till date", does not constitute information under clause 2(f) of RTI Act, 2005

The reply of the CPIO is in accordance with the provisions of RTI Act.

Regarding Points No.2 to 7 :- CPIO has informed that the concerned file in which amendment/framing of RR of IP&T AFS Gr. "A" has been processed is still under movement and not available with the CPIO.

4. In view of the aforesaid, I Abhay Kumar Singh, the Appellate Authority in the Department of Telecommunications have come to the conclusion that the Appeal is without merit and stands disposed off accordingly
