- Whether the DoT (HQ) OM No. 20-02/2013-SEA-I dated 31.12.2013 is applicable to Senior Accountants, Group-B (Non-Gazette). If not, provide the rule or/and guidelines is/are applicable for inter-Circle transfer of Senior Accountants posted in CCA office of DoT?
- Whether a Junior Accountant or a Senior Accountant can apply for inter-circle transfer to the same grade (as junior most), instead of below one rank. If yes, kindly specify the Rule and OM No(s).
- In case an employee SA is transferred under Rule-38 as JA to another Circle, whether protection of his/ her Pay structure/ Scale of Pay/Grade Pay/ Matrix Level accumulated by the service through ACP/MACP in that transferred post will continue ?. If yes, in either of the case, kindly specify the Rule(s).
