



**ORDER**

Consequent upon introduction of Modified Assured Career Progression Scheme (MACPS) by the Department of Personnel & Training as contained in O.M No. A.35034/3/2008-Estt.(D) dated 19.05.2009, approval of the Competent Authority is hereby accorded for grant of 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup> financial upgradation under the Modified Assured Career Progression Scheme (MACPS) to the following officials in the Pay Band-I of Rs 5200 – Rs 20200 in the Grade Pay with effect from the dates indicated against each of them:-

2. The financial upgradation under MACP shall be purely personal to the officials and shall have no relevance to their seniority position. As such, there shall be no additional financial upgradation for the senior officials on the ground that the junior official in the grade has got higher pay/grade pay under the MACPS.

3. Official may exercise their option under FR 22(i)(a)(1) to get their pay fixed in the higher grade pay either from the date of their financial upgradation or from the date of their next increment. The pay and the date of increment would be fixed



in accordance with clarification No.2 of Department of Expenditure's O.M No. 1/1/2008-IC dated 13.09.2008.

4. The financial benefits under the MACPS are subject to verification by Audit and necessary recovery, if any, will be made in the light of audit objections.

5. The financial upgradation shall be strictly as per the terms and conditions stipulated in the DOP&T's O.M No. 35034/3/2008-Estt. (D) dated 19.05.2009 and further amendments/clarifications issued from time to time in this regard.
