With ref. to the above subject, Tamil Nadu LSA, Department of Telecommunications had issued Notification vide Ref-1 above, to fill up the vacant posts in Sub Divisional Engineer (SDE) and Junior Telecom Officer (JTO) cadre on deputation basis from among the staff working in Central/ State Government/ Union Territories/ PSUs/ Universities/ Recognized Research institutions or Statutory and Autonomous bodies. The last date for receipt of applications mentioned in the above referred Notification was 20.08.2022.

**ANNEXURE-B****(A) Eligibility Criteria****I. Sub Divisional Engineer:-**

Officers from the Central or State Governments or Union Territories or Public Sector Undertakings or Universities or Recognized Research Institutions or Statutory and Autonomous bodies:

(a)

- (i) Holding analogous posts on regular basis in the parent cadre or department; or
- (ii) With two years of service in the level rendered after appointment thereto on a regular basis in posts in level-7 (Rs. 44900-142400) in the pay matrix or equivalent in the parent cadre or department; or
- (iii) With six years of service in the level rendered after appointment to the post on a regular basis the level-6 (Rs. 35400-112400) in the pay matrix or equivalent in the parent cadre or department. and

(b) Possessing the following educational qualifications and experience:

1.

- (i) Bachelor degree in Engineering or Technology in Electrical or Electronics or Electrical Communication or Computer Science or Telecommunications or Information Technology or Instrumentation from a University incorporated by an Act of the Central or State Legislature in India or other Educational Institutes established by an Act of Parliament or declared to be deemed as University under Section 3 of the University Grants Commission Act, 1956; or
- (ii) Passed Sections A and B of the Institution Examinations of the Institution of Engineers (India); or
- (iii) Obtained a Degree or Diploma in Engineering, from such foreign University or College or Institution and under such conditions as may be recognized by the Government for the purpose from time to time; or
- (iv) Passed Graduate Membership Examination of the Institution of Electronics and Telecommunication Engineers (India); or
- (v) Passed Graduate Membership Examination of the Institution of Electronics and Radio Engineers, London held after November, 1959; or
- (vi) Passed Associate Membership Examination Parts II and III or Sections A and B of the Aeronautical Society of India; and

2. Two years of experience in field of Telecommunications and Administration.

**Note 1:** The departmental officers in the feeder grade who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationist shall not be eligible for consideration for appointment by promotion.



**Note 2:** The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the central government shall ordinarily not to exceed 3 years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date on receipt of applications.

**For Ex-Servicemen:** The armed forces personnel of the rank of Subedar-Major (level 8), Subedar (level 7 and Naib-Subedar (level 6) or equivalent rank in Air Force or Navy who are due to retire or to be transferred to reserve within a period of one year and have the qualifications and experience as prescribed as above shall also be considered. If selected, such officers will be given deputation terms up to the date on which they are due for release from the armed forces; thereafter they may be continued on re-employment terms.

## **II. Junior Telecom Officer:-**

**(a)** Officers from the Central Government shall be eligible who are:

- (i) Holding analogous posts on regular basis in the parent cadre or department; or
- (ii) With five years regular service in posts in level 6 of the pay matrix (Rs. 35400-112400); and

**(b)** Possessing the following educational qualifications and experience:

- (i) Bachelor degree in Engineering or Technology in Electrical or Electronics or Electrical Communication or Computer Science or Telecommunications or Information Technology or Instrumentation from a University incorporated by an Act of the Central or State Legislature in India or other Educational Institutes established by an Act of Parliament or declared to be deemed as University under Section 3 of the University Grants Commission Act, 1956; or
- (ii) Passed Sections A and B of the Institution Examinations of the Institution of Engineers (India); or
- (iii) Obtained a Degree or Diploma in Engineering, from such foreign University or College or Institution and under such conditions as may be recognized by the Government for the purpose from time to time; or
- (iv) Passed Graduate Membership Examination of the Institution of Electronics and Telecommunication Engineers (India); or
- (v) Passed Graduate Membership Examination of the Institution of Electronics and Radio Engineers, London held after November, 1959: or
- (vi) Passed Associate Membership Examination Parts II and III or Sections A and B of the Aeronautical Society of India or
- (vii) Any other qualification which has been recognized by the Government in consultation with the Union Public Service Commission for the purpose of admission to the Engineering Services Examination.

**(B) Job Profile**

The functions of DoT field units are broadly divided into following verticals;

- (i) Service Compliance- CAF Audit, EMR Audit, Service Testing, Roll out obligation, etc.
- (ii) Technology- Secured dedicated communication network, Time Synchronization of Telecom Networks, Disaster Technology Management, interconnect Exchange, Inspections of Licensee Network, Advocacy & Public Awareness, etc.
- (iii) Security-Operation and Maintenance of CMS/ IMS, Curbing illegal activities/ Control over clandestine/illegal operation of telecom networks, Analysis of CDR/SDR, and other security activities assigned from time to time.
- (iv) Rural- Rural connectivity for DBT, verification of USO sites, RF coverage testing/ telecom connectivity checking, etc.
- (v) Admin, Legal, PG & Vigilance- Admin, PG, Building, Vigilance, Court cases & Misc., Admin activities, etc.

SDE/JTO level officers are at the working level and may be assigned work related to any of the above functional verticals.
