All the Pr. CsCA/ CsCA

The offices of the Pr.CCA/ CCA are performing the function of Pension Authorizing Authorities in respect of DOT pensioners. The pension is being disbursed through PS Banks and POs in case of DOT & BSNL pensioners. BSNL/ MTNL authorities are performing pension sanctioning/ processing functions in respect of their pensioners.

A need has been felt that the Pr. CsCA/ CsCA may reconcile the pension data with their Pension Disbursing Authorities (PDAs) and Pension Sanctioning/ Processing Authorities. A detailed process along with the time frame to be followed in this regard is furnished here as under-

Reconcilliation/ Purification of Pensioners' data:

STEP- I-

(i)All the Pr. CsCA/CsCA will prepare a list of all the pensioners/ family pensioners for whom they are Pension Authorizing Authorities. This will include-

- (a) The Pensioners of DOT/BSNL/MTNL/VSNL etc before 01.10.2000,
- (b) The pensioners of DOT/BSNL/MTNL/VSNL etc on or after 01.10.2000,
- (c) The pensioners pertaining to (a) & (b) above whose PPOs have been received from other units for authorizing disbursement of pension in that circle.
- Ii) The pensioners data may contain full particulars including name of the pensioner, Father's/Husband's name, Date of retirement, PPO Number, Basic pension, Amount of Pension commutation, Paying Bank/PO and any other information required. Separate information should be maintained for IDA/CDA/Pro- Rata/Combined service pension optee pensioners of MTNL etc.
- iii) This exercise must be completed by 30.04.2015.
- iv) A report of the above completion be sent to the Director (Accounts-I) in the enclosed 'Proforma-I' for necessary updation at DOT HQ.

STEP -II:

Simultaneously, the Pr. CsCA/CsCA may collect the information from all the Banks/POs regarding data of the DOT pensioners being disbursed through that agency and reconcile with their own records. In case of any discrepancy, coordination meetings may be held with Bank/PO authorities for getting the discrepancies removed/rectified.

STEP -III:

- i) By 31.05.2015, all the data prepared by the Pr. CsCA/CsCA and that received from Banks/POs must be reconciled and discrepancies intimated to the concerned agency for correction/ modification/deletion etc, if any, including the action to be taken by the all above.
- ii) Report in the enclosed Proforma -II be submitted by 07.06.2015.

STEP-IV:

While taking action in IIII above, if required, concerned Pension Sanctioning/ Processing Authorities viz; BSNL/MTNL etc may be contacted for necessary details coordinating with different authorities in this regard.

STEP-V:

The final figure so arrived in respect of all categories of pensioners be reported to the DOT HQ by 30.06.2015 in Proforma-III.

All the Pr. CsCA/ CsCA may carry out the above activities as per defined time schedule and intimate the action taken to the DOT as per prescribed time frame.
