Kind attention of all Wing Heads and concerned Sections is invited to various meetings on Court Cases held from time to time chaired by Secy(T)/ Spl. Secy(T) wherein apart from other matters CCMS has been regularly discussed. As per the decision in such meetings the officers at the level of JS/DDG are the nodal officers in respect of their charge. It was clearly clarified that for various matters relating to CCMS like obtaining Login ID & Passwords, facility for amending the details incorporated in CCMS and allowing access to CCMS to CCA Offices and TERM Cells located at different locations the requirements need be reported to IT Division and followed with them. It is learnt from IT Division that they are in the process of engaging an Agency for further handholding the CCMS and making further modifications wherever so required by respective Wings.

In view of the above it is requested that all Wings may ensure that they have intimated to IT Division the problems being encountered while using CCMS and may depute appropriate official to IT Division, (Director (IT-4)) for sorting out such matters and avoiding the communication gaps thereby.
