Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up **the post of Secretary, TRAI at its Headquarter in New Delhi on deputation on foreign service terms, initially for a period of two years.** The required qualification and experience for the said post are given below:-

<b>Qualification/ Experience →</b>	Officers of the Central Government, Public Sector Undertakings and Statutory and Autonomous Bodies:- <b>(a) holding a post in the Level-15 on substantive basis OR</b> <b>(b) who have been granted non-functional upgradation to Level-15 and have four years of regular service in the Level-14.</b> Preference will be given to those holding any or a combination of the following:- (i) Senior managerial position; (ii) Bachelor's Degree in Telecommunication Engineering from a recognized University or equivalent; (iii) Bachelor's Degree in Electronics & Telecommunication Engineering from a recognized University or equivalent; (iv) MBA Degree from a Recognized University or equivalent; (v) Master Degree in Economics/Commerce or Doctorate Degree in Economics/ Commerce.

3. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June, 2010, as amended from time to time. **The maximum age for appointment on deputation shall in no case exceed 58 years on the last date of submission of applications in TRAI.**
