Prosecution sanction in CBI case RC 2(A)/2003-BPL was given in respect of Sh. Sukumar Choudhary vide Order No. 9-22/2003-Vig.I dated 15.9.2003. Court of Spl. Judge (CBI), Bhopal has acquitted him vide judgement dated 13.2.2008. Against this acquittal judgement, CBI has filed Criminal Appeal No. 1524/2009 in the High Court of MP and the same is pending in the court. No RDA was against the officer in RC 2(A)/2003-BPL.
