

1. This hearing has been done through hybrid mode.

I.A. 3173/2024 and I.A. 3237/2024 (for exemptions)

2. These are application seeking exemption from advance service. Considering the nature of the matter, the exemptions are allowed.

3. Applications are disposed of.

I.A.2922/2024 (for impleadment) and I.A. 3172/2024

4. *I.A.2922/2024* is an application under Order I Rule 10 CPC seeking impleadment of one domain name and two Telegram channels (on the application Telegram FZ-LLC) which are using the mark 'POLICYBAZAAR' and 'PAISABAZAAR'. Further, *I.A. 3172/ 2024* is an application filed under Order XXXIX Rules 1&2 CPC seeking interim injunction against Defendants Nos. 60 to 62 and directions against Defendant Nos. 13 to 15 and 63 to 64. It is stated that Defendant Nos. 60 to



62 are rogue websites which do not have claim in the marks and are using the Plaintiff's mark fraudulently masking identity of the Plaintiff's and are offering identical/similar services defrauding the users.

5. The Registrar of the domain names of Defendant Nos. 60-62 is Defendant No.13- BigRock Solutions Ltd. It is averred that the said Domain Name Registrar (hereinafter, 'DNR') is enabling the infringement and passing off of the Plaintiff's services under its trademarks 'POLICYBAZAAR' and 'PAISABAZAAR'. Further, the Instagram page and the Facebook page of "mypolicybazaronline.com" are being hosted and operated on the Facebook. Therefore, Meta Platforms Inc. is sought to be impleaded as Defendant No. 64.

6. The two Telegram channels are https://t.me/paisa_bazaarr and <https://t.me/pasiabazaarofficial>, which are being communicated on Telegram channel.

7. Accordingly, considering the fact that three online domain names channels and social media accounts are being run using the mark 'POLICYBAZAAR' and 'PAISABAZAAR', it is deemed appropriate to implead the said parties from Defendant No. 60 to Defendant No. 63.

8. The interim injunction under Order XXXIX Rules 1&2 already operating against other various Defendants as per order dated 11th November, 2020, shall extend to the Defendant Nos. 60, 61 and 62.

9. The remaining directions in respect of the platforms shall also extend *qua* Telegram FZ-LLC, the DNR -Defendant No. 13- BigRock Solutions Ltd., as also Defendant No. 64 i.e., Meta Platforms Inc.

10. The Plaintiff has made out a *prima facie* case for injunction, case for grant of an *ex parte* ad-interim injunction. The balance of convenience lies



in favour of the Plaintiff, and irreparable harm would be caused to the Plaintiff, if the Defendants' activity are not injuncted. The following reliefs are accordingly granted at the interim stage:-

- (i) Defendant Nos. 60 to 62, their business associates, partners, directors, principal officers, family members, servants, agents, dealers, distributors, franchisees and anyone acting for and on their behalf shall stand restrained from using the mark/name/logo POLICYBAZAAR or PAISABAZAAR or any deceptively similar variations thereof, in any manner whatsoever, either as a part of the domain name/UPI Id/email id/Instagram or Facebook handle/Telegram channel or a trade mark, service mark or trading style/corporate name in relation to any goods or services either on the internet or otherwise;
- (ii) Defendant No. 13 is directed to block/suspend the impugned domain names/ webpages and to maintain status quo in relation the impugned domain name of Defendant No. 60 during the pendency of this suit;
- (iii) Defendant No. 13 is directed to disclose the name, contact and payment details of Defendant No. 60;
- (iv) Defendant Nos. 14 and 15 are directed to issue a notification calling upon the various internet and telecom service providers registered under it to block access to the websites hosted by Defendant No. 60 on the impugned domain names/ webpages;
- (v) Defendant No. 63 is directed to remove/ block Telegram accounts/channels of Defendant Nos. 61 & 62 and delete all other



groups/community groups/channels created by/ administered by the said Defendants and/or misusing the Plaintiff's trademarks in their communications;

(vi) Defendant No. 64 is directed to take down/delete/suspend the Instagram and Facebook pages/accounts of Defendant No. 60 accessible at <https://www.instagram.com/mypolicybazar/> and at <https://www.facebook.com/mypolicybazar> and delete/suspend all other pages created by/ administered by the said Defendant misusing the Plaintiff's trademarks;

(vii) Defendant No. 64 is further directed to disclose the basic subscriber information/identity of users/owners of the channels impleaded as Defendant Nos. 61 & 62;

11. Compliance of order XXXIX Rule 3 be done within one week.

12. Reply to the application be filed within four weeks from the service of the present order, along with the paper book.

I.A. 3236/2004 (under Order XIII A) and CS(COMM)-471/2020

13. This is an application seeking summary judgement against Defendant Nos. 1 to 8, 18 to 26, 29 and 31 to 39. Issue notice in this application to the ld. Counsels who are appearing in the matter.

14. If any of the DNRs and other infringing domain names are not appearing through counsels, the application shall be simply sent through email by the ld. Counsels for the Plaintiff.

15. List on 21st March, 2024.

1. The case, which the plaintiff has broadly set up, is as follows.

1.1 The plaintiff claims that it is the owner of the well-known trademarks “POLICYBAZAAR” and “PAISABAZAAR”.

1.2 It is also averred on behalf of the plaintiff that it operates two popular websites i.e. www.policybazaar.com and www.paisabazaar.com *qua* its insurance and financial products’ respectively.

1.3 Mr. Kapil Wadhwa, who appears for the plaintiff, says that the plaintiff has partnered with various insurance companies and banks as also mutual funds for offering insurance and financial products to the consumers.

1.4 In sum, it is claimed that the plaintiff is a web aggregator and by virtue of the information put out on its websites, it is able to offer choices to the consumers *qua* insurances and financial products that are put out for sale by various insurance companies and banks.

1.5 The plaintiff claims that it has approached this Court for necessary relief in view of the fact that defendant nos. 1 to 8 are operating rogue websites and consequently duping the public at large by having them believe

that the websites operated by them have their source in the plaintiff.

1.6 Mr. Wadhwa, thus, submits that the activities of defendant nos. 1 to 8 are resulting not only in the infringement of the plaintiff's registered trademarks but also other tortious acts such as passing off, dilution and tarnishing of the plaintiff's trademark as also cyber squatting.

2. I have heard Mr. Wadhwa and perused the documents filed along with the plaint.

3. To my mind, the plaintiff, at least at this stage, has been able to establish a *prima facie* case in its favour.

3.1 The balance of convenience also appears to be in favour of the plaintiff given the extent of revenue generated by it. The details *qua* sales revenue are set out in paragraph 8 of the plaint.

3.2 The amount spent by the plaintiff on advertising, the figures *qua* which are set out in paragraph 9 of the plaint, also establish the fact that the balance of convenience, presently, is tilted in favour of the plaintiff.

3.3 Since defendant nos. 1 to 8, appear to be running rogue websites, they could cause irreparable damage, not only to the plaintiff but also to the public at large.

4. Given these circumstances, issue summons in the suit and notice in the captioned application to the defendants *via* all means including e-mail.

4.1 In the meanwhile, till the next date of hearing, defendant nos. 1 to 8, their agents, employees, partners and associates are restrained from using the trademark/logo "POLICYBAZAAR" and "PAISABAZAAR" or any other mark or logo which is deceptively similar to the aforementioned marks. This injunction will also operate *qua* the respective domain names administered by defendant nos. 1 to 8.

4.2 Furthermore, the concerned domain name registrars [DNRs], whose details are given hereafter, will block/suspend the websites of defendant nos. 1 to 8, which are registered with them.

4.3 Besides this, defendant nos. 14 and 15 shall issue notifications to various internet service providers and telecom service providers to block access to the infringing domain names of defendant nos. 1 to 8.

5. This apart, leave is given to the plaintiff to approach this Court to array other rogue website(s), who carry on similar activities, *albeit* illegally, as and when the same comes to its notice.

6. The plaintiff will comply with the provisions of Order XXXIX Rule 3 of the Code of Civil Procedure, 1908 within five days of the receipt of a copy of the order.

7. List the matter on 03.02.2021.



Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
