

Subject: Allocation of separate numbering series exclusively for service and transactional voice calls as per TCCCPR, 2018 notified under TRAI Act-1997.

It has been decided to modify DoT letter No. 16-2/2023-AS-III/TRAI/58, dated 28.05.2024 to allot a separate numbering series '1600' exclusively allotted for telemarketers to facilitate service and transactional voice calls as per Telecom Commercial Communication Customer Preference Regulation (TCCCPR), 2018.

2. The structure of this numbering series has been decided as follows:

Principal Entity (PE)	Numbering Series Pattern	Range of ABC	Range of XXX
Government (Centre/State) and Regulators, Financial Entities Regulated by RBI, SEBI, PFRDA, IRDA etc.	1600ABCXXX	000-999	000-999

(Note: If any other type of entity requires assignment of number resources under this series, the same may be intimated by TRAI.)


Where: **XXX**= Block of 1000 numbers (000-999) available to a particular ABC (a particular TSP in a particular LSA)

3. Numbering resources are scarce in nature, hence keeping in view the scarce resources, it has been decided that, after initial allocation of 1000 numbers (XXX) to each TSP in each LSA (represented by a particular value of ABC) in the '1600' Series, subsequent allocation to a particular TSP in a particular LSA should be done only after 75% utilization of allocated numbering resources by the TSP in that particular LSA.

4. Further, the TSP shall ensure adequate verification of each and every entity before assigning a number from '1600' series. The TSP shall obtain an undertaking from the seeking entity that it will use the number assigned from '1600' series exclusively for service and transactional voice calls as per TCCCPR, 2018 notified under TRAI Act-1997 only. The TSP shall make it clear to the entity that it will be responsible for proper and bonafide use of the assigned number from '1600' series. Instructions issued by the Licensor in this regard from time to time shall be scrupulously followed. Further, the TSP shall assign 10 digit numbers only from '1600' series.
