Subject: Inviting nominations for Constitution of National Working Group (NWG)-2 corresponding to ITU-T Study Group-2 (Operational aspects of telecommunications and ICTs) for the Study Period 2025-2028

Telecommunication Engineering Centre (TEC) is the nodal agency of Department of Telecommunications (DoT), Government of India, for constituting various National Working Groups (NWGs) corresponding to respective International Telecommunication Union (ITU-T) Study Groups(SGs). TEC is also National Standardization Body (NSB) for telecom and ICT Sector and mandated to participate and submit contributions in the meeting of other standardization bodies such APT, ETSI, 3GPP, 1M2M etc.

2. The International standards (ITU-T Recommendations) developed by ITU-T Study Group 2 (SG2) address the requirements of the structure and functionality of telephone numbers used for international communication, identification of roaming mobile terminal, ITU's international Numbering Resource database and management of telecom services, network and equipment among others.

The broad list of topics for study/recommendations relating to SG2 is given below:

- Application of numbering, naming, addressing and identification plans for fixed and mobile telecommunication services (NNAI)
- Routing and interworking plan for current and future networks routing and interworking
- Service and operational aspects of telecommunications, including service definition.
- Requirements, priorities and planning for telecommunication/ICT management and operation, administration and maintenance (OAM) Recommendations
- Architecture, security, and evaluation of networks for operations, management and maintenance.
- Interface specifications and specification methodology

3. As per the prevalent practice, NWGs are reconstituted at the beginning of each study period for the corresponding ITU-T Study Groups. Therefore, TEC is in the process of reconstituting National Working Group 2 (NWG-2) corresponding to ITU-T SG2 for the Study Period 2025-2028. NWG-2 is chaired by DDG(RC), TEC and comprises experts from industry/start-ups, R&D Organizations, academia, service providers, Government organizations etc.

4. As the development of standards is a consultative and collaborative process, nominations of subject matter/ domain experts are solicited for membership in the NWG -2 being constituted in TEC for the Study Period 2025-2028.
