- g) Pay Fee of Rupees Five Thousands (5000/-) for License which will be valid for 20 years subject to validity of foreign FRTOL, through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) [also refer Table-1]

**4) Renewal of RTR (C)**

- b) Attested copy of valid Foreign FRTOL (commonwealth countries and Philippines)

- c) Attested copy of Experience Certificate of 30 Hrs. of flying in an Aero Mobile Station (Certified flying Log Book including the first page bearing the name of candidate) or an experience certificate of not less than three months in a station working in the Aero-Mobile service.
- d) Passport size photos-02 Nos.
- e) Issued for 20 years subject to the validity of foreign FRTOL.
- f) Renewal fee of Rupees Five Thousands (5000/-) along with late fees (if any) through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) [also refer Table-1]

**5) Issue of RTR (A) New License**

- b) License will be issued from concerned RLOs

**6) Renewal of RTR (A)**

- a) **Application complete in all respect, for the purpose of RTR(A) Renewal may be send to the office, which issued initial RTR(A) license**

- c) Attested copy of Experience Certificate of 30 Hrs. of flying in an Aero Mobile Station (Certified flying Log Book including the first page bearing the name of candidate) or an experience certificate of not less than three months in a station working in the Aero-Mobile service or renewal by test (RTR(A) Part I) as per order in force.
- d) Copy of RTR(A) license along with latest renewal slip (if any).
- e) Attested copy of Date of Birth certificate (DOB)
- f) Passport size photographs- 02 Nos.
- g) Payment of rupees Five Thousands (5000) for 20 years and Ten Thousands (10000) for life time { late fess (if any)} through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) [also refer Table-2]

h) Late fee as per rules [ @ 2% per month or part thereof, subject to the minimum of Rs. 250/- per license. In case the delay is more than one year the said late fee shall be applied in an annually compounded manner].

**Note:** - (i) All Payments has to be made through NON TAX RECEIPT PORTAL(NTRP) only and enclose a copy of the payment receipt as a proof of payment with application completed in all respect. It may be noted that while making payment through NTRP, due care must be taken to make payment to Department of Telecommunications (DoT), for the purpose under RTR (A) License only. Payment made to any other Department/Ministry will not be taken into consideration. - d) Late fee as per rules [@ 2% per month or part thereof, subject to the minimum of Rs. 250/- per license. In case the delay is more than one year the said late fee shall be applied in an annually compounded manner].
- e) Payment through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) for Renewal of GMDSS (GOC) License – Rs 5000/- for 20 years/ or Rs. 10000/- for life time [also refer Table-3].

- Payment through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) for General or Restricted Grade Amateur Station License - Rs 1000 for 20 years/ -Rs. 2000 for life time **[also refer Table-5]**.

### 13) Renewal of Amateur Radio License

- Application (Form Annexure-7) with declaration of making applicable contacts in amateur radio as per rule.
- Late fees as per rules [@ Rs. 100 per six months]
- Copy of previous renewal slip/Licence Certificate.
- Payment through NTRP Portal (<https://bharatkosh.gov.in/NTRPHome/Index>) for General or Restricted Grade Amateur Station License - Rs 1000 for 20 years/ -Rs. 2000 for life time. **[also refer Table-5]**
