NOTICE FOR INVITING PUBLIC COMMENTS

Subject: - Inviting public comments on adoption of TSDSI transposed 3GPP standards for Release 13 to 17 (Total 279 Documents) as an outcome of TSG#103 as a National standard by Telecommunications Engineering Centre (TEC) – reg.

Telecommunication Engineering Centre (TEC), Department of Telecommunications (DOT) has approved a policy for the adoption of domestic/international standards into National Standards. "Standardisation Guide" – a policy document for the adoption of telecom and related ICT standards defines the process of adoption/ratification of TSDSI/international standards including institutional mechanism, process of adoption, maintenance of standards, numbering plan, stakeholder consultation etc. The Standardisation Guide can be accessed at <https://tec.gov.in/standards-adoption-policy>.

Telecom Standards Advisory Committee (TSAC) – a Standing apex committee under the chairmanship of DDG (Standardisation), TEC, has decided to initiate the process of adoption of TSDSI transposed 3GPP standards for Release 13 to 17 (Total 279 Documents) as an outcome TSG#103 as a National standard.

3. As a next step in adoption process, all stakeholders are requested to offer their comments on the above mentioned TSDSI transposed 3GPP standards for Release 13 to 17. The details in this regard are as given below:-
