ORDER


2. The officer may exercise his option for fixation of pay under relevant provision of FR-22(I)(a)(1) within one month from the date of promotion.

4. The adhoc promotion of Shri Arvind Chawla (Staff No. 8079) to Advisor Grade (HAG+) of ITS Group 'A', issued vide Order No. 12-04/2020-STG-I(Part-I) dated 21.08.2020 stands regularized w.e.f. 21.08.2020 or from the assumption of charge in higher grade, whichever is later.

5. The above promotion order is being issued after obtaining the vigilance clearance from the Vigilance Branch DoT HQ. However, in case it comes to the notice of the Controlling Authority that any Disciplinary case is pending or any penalty is in operation against the officer, the officer should not be promoted without obtaining specific approval of this Office.
