**Sub:- Disbursement of pensionary benefits to all combined service optee absorbed employees of MTNL-reg.**

Kindly refer to DOT OM NO.42-4/2012-Pen (T) dated 28.04.2014 and in continuation to this office OM No.26-10/TA-I/2014 dated 26.05.2014, 30.05.2014, 24.06.2014, 03.09.2014 & 28.10.2014, the following has been decided for taking over the pension liability of combined category of MTNL pensioners retired prior to April 2014 by the O/o the Pr. CCA Delhi & Mumbai

- 2) The Pr. CCA, Delhi and Mumbai will provisionally takeover the disbursement of pension in respect of covered categories of MTNL pensioners retired prior to April 2014 w.e.f. January 2015. The Pr. CCA, Delhi and Mumbai will maintain the record of such provisional payment which will be reconciled after finalisation of pension cases. The reimbursement of pension payment to MTNL will cease w.e.f. January 2015.
- 3) MTNL will obtain an undertaking regarding refund of excess payment of pension etc (Annexure I), mandate form (Annexure II) and life certificate as on November 2014 (Annexure III) from all the covered categories of MTNL pensioners.
- 4) The ED MTNL Delhi & Mumbai as heads of the office will forward to Pr. CCA, Delhi and Mumbai, 1000 pension cases per month per CCA complete in all respects along with the undertaking from the pensioners, mandate form and the life certificate for processing of pension cases.
- 5) The Pr. CCA Delhi and Mumbai will finalise the cases received from MTNL per month in all respect in accordance with the instructions issued vide OM No.26-10/TA-I/2014/1892-1942 dated 26-05-2014 and 25.09.2014.
- 6) The CMD, MTNL will extend support to the Pr. CCA, Delhi and Mumbai for providing requisite manpower, infrastructure and furnished space in the vicinity of the CCA Offices temporarily till the final takeover of all the existing pensioners.
- 7) The progress report will be forwarded to the Director (Accounts-I), DOT HQs by 15<sup>th</sup> of every month in the enclosed proforma (Annexure IV).
- 8) The detailed instructions regarding functioning of the O/o Pr. CCA, Delhi & Mumbai as Pension Disbursing Authority (PDA) are being issued separately.
