This reconciled report should not be signed by the officer below the rank of JAG. The prescribed format is enclosed as Annexure-II.
 - Mismatch Report for Quantum of Spectrum and rates applicable thereon Mismatch report for the Quantum of Spectrum allocated to the service providers and rates applicable thereon is also to be sent to WPF wing as and when it comes to notice of the O/o CCA. The prescribed format is enclosed as Annexure-III.
