**Reference:- This office letter No. BMRCL/ST-0002/STAFF/2009-10/1956 of 27<sup>th</sup> Sep. 2014.**

Bangalore Metro Rail Corporation Ltd. (BMRCL) is a special purpose vehicle of Govt. of India and Govt. of Karnataka entrusted with the task of completion of Bangalore Metro Rail project. We have so far operationalized a route length of about 17 kms out of 43 kms sanctioned under Phase-1 project. Further, Phase-2 is sanctioned for about 72 kms recently by GoI consisting of extensions to these lines and two new lines. The entire project is to be completed over the next 6 years in different stages.

Metro Railway system has several sub-systems and Communication plays extremely important role in Metro Train functioning & operations. Systems such as TETRA, Giga bit Ethernet, Passenger Information System, SCADA, Telephone and Surveillance system in Metro requires appropriate interfacing for satisfactory working of a Metro Train. This requires expertise in the field of telecommunication.

In order to meet its human resource requirement, BMRCL is drawing manpower at senior executive level from various Govt. organizations, including Department of Telecommunications (DoT), Govt. of India. It is to state in this connection that an officer in JAG of ITS Group 'A' is required for this Metro to take up a managerial position in Bangalore in our organization and a request was made for the same vide above reference. The officer is expected to manage project execution including Tendering, Planning and commissioning of various telecommunications and IT related works of Bangalore Metro. The details of the post for deputation are in the Annexure-1.

It is requested that DoT may kindly forward a panel of suitable JAG ITS Group 'A' officers for the above purpose to Bangalore Metro.

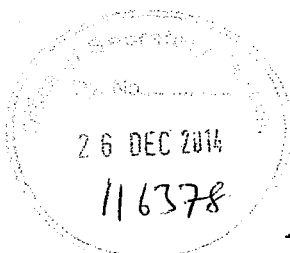
