Subject : Obtaining the service bond from the Junior Telecom Officers of the Department of Telecommunications – regarding.

---


In continuation of this Department's OM of even number dated 26.06.2015 on the above mentioned subject, the undersigned is directed to state that the representations received from the JTOs of 2013 & 2011 (Reserve List) Batch relating to waiving of the provision of execution of service bond have been examined in accordance with provisions of Recruitment Rules, 1999 of JTO. It is intimated that –

- a). The candidates of JTO-2013 & JTO-2011 (Reserve List) Batches have been duly intimated about the execution of bond for a period of 5 years from the date of appointment as JTO while issuing the offer of appointments to them for the post of JTO and sufficient time has been given to them to join the post of JTO.
  - b). Candidates have also been intimated that the matters not specified in the offer of appointment, they will be governed by the relevant rules and orders of the Government in force from time to time generally applicable to the officers of Central Government. Therefore, non-inclusion of transfer of bond clause in the offer of appointment shall not be a reason to non-execution of service bond.
  - c). The bond proforma appended to JTO Recruitment Rules-1999 has been vetted by the Department of Legal Affairs.
  - d). The Recruitment Rules of ADET do not stipulate any provision of obtaining service bond whereas such provision is available in the JTO Recruitment Rules, 1999 applicable to the JTOs appointed through ESE-2011 and 2013.
2. It is reiterated that effective date for execution of service bond is the date of appointment of JTOs of 2013 & 2011 (Reserve List) batches in the Training Centre/DoT.
