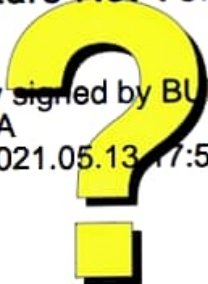


**OFFICE MEMORANDUM**

Subject: Clarification regarding full and final settlement of bills/claims pertaining to LTC Special Cash Package Scheme.

The undersigned is directed to refer to this department OM of even no. dated 31<sup>st</sup> March 2021 clarifying that submission of bills/claims with regard to LTC Scheme may be entertained and settled by Ministries/Departments not later than 30<sup>th</sup> April 2021.

2. Queries have been received in this department to extend the date for submission of bills/claims and settlement beyond 30<sup>th</sup> April, 2021. Keeping in view of the situation existing due to Covid-19 pandemic, it has been decided that submission of bills/claims may be entertained and settled by Ministries/Departments not later than 31<sup>st</sup> May, 2021.
